



TooToo Dog Care- Rules, Regulations, and Waiver

Injuries & Illness: At TooToo Dog Care, we strive to provide your dog with excellent care and a fun experience during their stay. Although all dogs are supervised and monitored at all times, injuries can still occur while dogs are playing together such as scratches, cuts or sprained joints. Such injuries are rare, but they happen at all doggie daycares and boarding. In Addition, while infrequent, dogs can get into fights, even under close supervision. Common areas for bits as a result of these fights are the snout, ears, tuft of the neck and paws. At TooToo Dog Care, we have procedures to screen dogs for aggressive behavior and we do not allow aggressive dogs to play with other dogs. However, even the friendliest of dogs can get into fights with very little or no warning. If your dog suddenly shows aggressiveness, even passed the screen test, (s)he will be in time out room. In addition to injuries, it is possible for dogs to transfer illness such as upper respiratory infections and kennel, even with the required vaccinations and boosters. This is just like at a daycare for children where illness such as pink eye and the flu can be transferred from one child to another. Such illnesses do not occur often and all dogs must have the necessary vaccinations to check-in.

Abandonment of Dogs: I understand if I do not pick up my dog by 3 days after the agreed upon pick up date, a letter will be sent regarding the dog abandonment. Should the dog not be removed within the specified time, I, the client, hereby relinquish all claims to my dog, but shall not relieve my contractual liability of any treatment, boarding or care furnished. I agree not to bring my dog into the facility if my dog is showing any signs of being sick, has fleas and/or ticks (owner will be charged for treatment), or that its behavior may expose the safety and health of other pets and/or our staff. 3. I certify that I have informed TooToo Dog Care of all dog and human aggression. I agree that I am responsible for any harm caused by my dog while in the care of TooToo Dog Care. I shall indemnify TooToo Dog Care against any claims made against it or for losses or damages suffered by TooToo Dog Care as a result of my dog. Initial _____

I understand that any time during the stay, my dogs shows constant aggression to other dogs or human (I agree that my dog's aggressive behavior will be determined by TooToo Dog Care personnel), I will be contacted to removed my dog from TooToo Dog Care immediately. Before my dog being removed by the me, my dog will be put into an individual room. If I cannot be reached, the emergency contact on the application form will be contacted to remove the dog. TooToo Dog Care reserves the right to permanently remove a dog from its facility at anytime. Initial _____
5. I understand that in the event my dog appears to be ill or at significant risk of experiencing a medical problem, TooToo Dog Care will attempt to contact me for instructions prior to seeking veterinary care. If I cannot be reached, I agree that TooToo Dog Care may use its reasonable discretion in seeking veterinary care on my behalf and I will be responsible for all related expenses. I understand that TooToo Dog Care will attempt to use my preferred veterinarian, but if my preferred veterinarian is unavailable or other circumstances mandate, I authorize TooToo Dog Care to use the veterinarians of its choice. I agree TooToo Dog Care will not be liable for the actions and decisions of the veterinarian. I also agree to be responsible for any reasonable fees assessed by TooToo Dog care for emergency care and transportation. Initial _____
6. I agree I will pick up my dog on the agreeable specified date and time frame. If I do not pick up my dog on time, hourly daycare or full day daycare will be charged whichever is less. If I do not pick up my dog before TooToo Dog Care close time, additional overnight charge will be applied upon departure. Initial _____
